

# 1 Disclosure of Methods & Materials

- Provide the client ratings for materials used in project as related to LEED Certification and sustainability when available.
- Use renewable materials such as bamboo hardwood, cork, and recycled carpet.
- Use non-toxic materials during installation of product as applicable.
- Provide Indoor Air Quality CRI Green Label Registrations when available.
- Follow CRI 104 Standard for Installation of Commercial Carpet.
- All trucks run on bio-fuels.
- Use recyclable plastic containers and wraps to move materials to and from jobsites.

# 2 Reclaim and Reuse Removed Carpet

- Extensive "Reclamation Interview" with each installation. FRC must know what happens to the carpet if it is to be removed. We stress re-use over destruction.
- Any unused material from a job is returned to FRC warehouse.
- FRC believes in "Second Life." We wash gently used carpet tiles and donate them for use in needy organizations.

# 3 FRC ReCycle Program

- FRC provides free recycling services - with or without project ownership.
- FRC trailers divert 40,000 lbs of carpet from landfills every time they are filled.

# 4 Carpet Maintenance

- Use of Carpet and Rug Institute (CRI) Green Label approved chemicals, methods and equipment for the cleaning and maintenance of carpets.
- Provide training to client's existing facility staff to uphold CRI environmental standards.

## Doing Our Part

- FRC Employees are encouraged to reduce waste.
- Recycling is provided for materials used in daily office work (paper, plastic, toner, etc.)
- FRC's fleet of trucks all run on Bio Diesel.
- FRC offers employees a full service kitchen with dishes and utensils to reduce use of disposable materials. We also provide and encourage use of mugs for beverages rather than disposables.
- FRC is in the process of installing new energy efficient lighting systems in building.
